To meet this requirement, he/she must present his/her current NPC card, current NPC receipt, or purchase an NPC card at this event (\$125). (2) Each competitor must be an amateur in good standing with the NPC. (3) MASTERS (Men & Women): Each competitor in these Divisions also (a) by April 20, 2019, must have reached the age for the respective Masters class in which he/she has chosen to compete and (b) must provide proof of age with a birth certificate, driver's license or state I.D. TEEN MEN: Each competitor in this Division also (a) must have reached his 13th birthday, but not his 20th birthday by May 10, 2019 and (b) must provide proof of age with a birth certificate, driver's license or state I.D. Athletes this event is open to all residents throughout the USA..

**Awards:** BEAUTIFUL CUSTOM AWARDS will be presented to places 1-5 in all classes. Beautiful Custom Awards will be awarded to the Men's and Women's Overall Champions.
